

# Report on Sectarian Massacres and Genocide against Alawites in the Syrian Coast

## Introduction:

Before we start recounting the events of 06/03/2025 to the present day, we will mention two important details

- Since the fall of the Assad regime, Alawites belonging to the military and police forces have surrendered their weapons, regularized their status, handed over their identities after assurances from the current government, and returned to their civilian lives.

- Violations against Alawite civilians and military personnel have occurred over the past three months, including verbal and physical attacks, arbitrary dismissal, immediate dismissal from state jobs, killings, arrests, and other documented violations.

In addition to many massacres in various Alawite areas such as Fahil and Ain Shams.

## Events in Syria are characterized by massacres, genocide, and sectarian violence:

**Massacres** The systematic killing of large numbers of civilians in gruesome circumstances, often without distinguishing between combatants and civilians.

- **Genocide** According to the United Nations Convention, genocide occurs when a group is deliberately subjected to physical extermination.

**Sectarian violence and ethnic cleansing:** When attacks are based on the religious identity of the victims, indicating sectarian-motivated violence.

Based on these definitions, it is clear that the current events in Syria go beyond mere killing.

They represent a targeted and organized campaign against a specific group, which amounts to genocide and ethnic cleansing.

You will see evidence of this in this report.

## **Documentation methodology:**

This report was prepared based on:

- Direct testimonies from survivors and victims' families.
- Photos and videos by residents in the areas of the massacre.
- Field damage assessment.
- Documents and investigations issued by international human rights organizations and the Syrian Observatory for Human Rights.

## **The General Context of The Event:**

We start here with the events **of 06.03.2025** and what happened afterward:

On Thursday, **March 6, 2025**, Public Security Directorate forces launched a security campaign.

### **The events were as follows:**

A Public Security force entered the village of Al-Dalia in the Jableh countryside to arrest a young man named "M.M." because of Facebook posts.

The people refused to hand him over until the group that entered the village presented proof of their affiliation with General Security.

Eyewitnesses reported that the group arrested six other young men and shot the residents because they refused to hand over the young man without an official arrest warrant.

After the arrest, the security patrol was ambushed by remnants of the former regime, prompting Public Security forces to randomly target the village. The residents of the village of Al-Dalia and the neighboring village of Al-Duwair in Abda - two villages on the Syrian coast about 23 kilometers from the city center - were surprised by an air bombardment from a helicopter, coinciding with random artillery shelling from the Naval College in Jableh, where government forces are stationed.

Interim government forces tried to bombard the village with artillery. However due to the village's distance from government positions, the shells landed in neighboring villages.

This escalation forced civilians to take to the streets - fearing that the shelling would spread to other villages and in solidarity with each other, chanting "No to shelling! The Syrian people are one!" In response, Interim Government forces moved in and dispersed this peaceful gathering with gunfire.

After these events, citizens took to the streets of Jableh chanting, "We demand the protection of civilians."

At the same time, official social media pages affiliated with the Department of Operations launched a campaign claiming that this peaceful gathering was actually an armed gathering of remnants of the former regime's army.

Given how quickly events unfolded - from the beginning of the bombing to the attack on civilians that took only a few hours, it became clear that the entire operation was pre-planned.

Later, through social media, it became clear that some groups were trying to capitalize on the tense security situation along the coast. The interim government in Damascus referred to these groups as "remnants of the regime." This group attacked the Interim Government's Public Security Forces, took control of some neighborhoods and key positions, and expelled the faction from Jableh. Their leader, Mekdad Fathiya - known on social media as the leader of the anti-government armed faction - vowed to restore security to the area. However, civilians, unwilling to take up arms against the interim government forces, opposed any clashes. Calls for demonstrations stopped to prevent them from being exploited by regime remnants.

After the withdrawal of public security forces from areas where regime remnants had appeared - such as the countryside of Jableh and Qardaha - the legitimate government declared general mobilization. Calls for jihad against a particular sect were issued from mosques, as documented in recorded videos. Extremists in Idlib, Damascus and Deir ez-Zor called for volunteers to be sent to the coast.

These government-backed forces began moving toward the coast with heavy weapons. Many extremists joined these forces in response to jihadist calls from mosques.

Documented videos showed these forces citing religious fatwas, especially those of Sheikh al-Islam Ibn Taymiyyah, who is accused of inciting violence against Alawites. This provided religious justification

The observers noted that the authorities took no action to stop these calls, further fueling the violence.

The convoys entered via the M4 highway.

On the morning of **March 7**, they were ambushed by an armed group of regime remnants in the village of al-Mukhtariya. This sparked swift and brutal retaliation, leading to mass killings of local residents who had stayed in their homes for fear of clashes. More than 140 people lost their lives.

At the same time, the neighboring villages of Shalfatia and Shir near the M4 road were subjected to similar attacks against unarmed civilians. These attacks included

- Systematic massacres of Alawite women, children, youth, young men and elders, killing more than 120 unarmed people. **(below you see links to the evidence)**
- Burning and destroying properties and homes.
- Looting of homes, cars and shops, resulting in widespread destruction in these targeted areas.

As the massacres escalated, neighboring villagers fled to remote rural areas and forests in search of safety. These three massacres were among the first crimes committed in the early hours of **March 7**.

When these armed factions reached the villages of Baniyas, brutal massacres of families followed.

**On 07.03.2025**, the residents of Baniyas - especially those living in the neighborhoods of al-Qusour, al-Murooj, and the police residences - woke up to raids carried out by armed elements of the General Administration in Damascus. A curfew was imposed on the city.

The city witnessed all kinds of violations:

- A massacre of entire families, including women and children.
- Looting of houses and cars.
- Burning and destroying cars and shops.
- Mass arrests and the disappearance of many residents whose fate is still unknown.
- The brutal sectarian campaign has continued unabated, with no response from Public Security despite civilians' pleas.
- Doctors, engineers, academics and teachers - along with the elderly, women and children - have been killed in horrific ways, including by shooting, slaughter and burning.
- Meanwhile, a security cordon was imposed on Baniyas to prevent civilians from fleeing.
- The perpetrators bragged about their massacres, posting numerous videos and photos documenting their crimes. The next day, **March 8, 2025**, as the killings continued, some residents of central Baniyas (from the opposition sect) tried to intervene to stop the massacres, but they were met with gunfire and threats from armed groups, forcing them to retreat.

One of the largest documented massacres was the massacre of the Qusour neighborhood in Baniyas, where a large number of residents were killed simply because of their Alawite sectarian affiliation.

Reports circulated among locals that government security forces were disposing of large numbers of bodies by throwing them into the sea.

**On March 9, 2025**, after two days of continuous violence, public security forces intervened to stop the attacks - in particular

Groups coming from Idlib continue to target the population on the outskirts of the highway and villages that have been subjected to massacres in the Jableh area: Hmeimim, Basasin, Ain al-Arous, Jarfas, and villages in Latakia such as Sunobar and Muzaira.

They killed people in cold blood, either by shooting them, slaughtering them or even running them over with cars, vehicles and automobiles.

The civilian population lived in terror as property and bodies were burned.

Those who were killed in their homes remained wrapped in blankets near their families, as it was forbidden to bury the dead.

Some civilians wrote the word "Sunni" on their shops to protect them from theft and vandalism, signaling the sectarian dimension of these movements.

**On the 10th and 11th**, Garfis and Hreissoun were subjected to the same methodology

Killing, stealing, destroying and burning.

At dawn on Sunday, **March 10, 2025**, public security forces began putting out fires in the city, clearing the streets, and burying the dead. They put out fires in the city, cleared the streets, and buried many bodies in mass graves.

They also put pressure on residents to hide the facts and force them to seek protection only from public security. They forced them to say that the remnants of the regime were the ones who committed these crimes.

The authorities are trying to intimidate people into adopting their version of events.

The true number of victims is still unknown, violations and killings continue, and the government security forces are trying to change the bad image and loss of trust, especially since a good part of the perpetrators of violations are members of the government security forces.

The coast region is suffering from water and food shortages and power outages. In addition to the lack of trust and insecurity, a large number of people are spending their nights in farmland and forests, and looting and theft continue.

Security and livelihoods are desperately needed, and people are demanding to bury the bodies of their children.

Around **10,000** people have fled to the Russian base in Hmeimim, and there is a mass exodus and flight toward Lebanon.

More than **1,500** people are missing.

**Number of victims registered so far: 44 sectarian massacres claimed the lives of 1093 citizens.**

The personalities in charge of the investigation are of one color, have no credibility, are affiliated with one party, the authority, and are not independent.

**It should be noted that the armed factions were reintegrated on 29.01.2025**

**Thus, the authority is responsible for any violation**

**The announced committee is only tasked with investigating what happened on 06.03.2026, given that the massacres started on 07.03.2026 and are still ongoing**

## **Humanitarian and legal impact**

- Violations of international law
  - Genocide: Targeting a specific group based on sectarian identity.
  - War crimes: Deliberately targeting civilians and committing mass killings.
  - Crimes against humanity: forced displacement, torture, and field executions.
  
- Humanitarian impact
  - Forced displacement: More than 100,000 people have fled targeted areas for fear of future attacks.
  - 200,000-250,000 people directly affected
  - Psychological crisis: Survivors suffer from post-traumatic stress disorder due to the brutality of the crimes.

- Physical damage: Many villages have been destroyed, exacerbating the humanitarian crisis. More than 800 houses.
- Legal proceedings
  - Open an independent international investigation under the supervision of the International Criminal Court.
  - Impose sanctions on individuals and groups responsible for these massacres.
  - Prosecute the leaders and financiers of these crimes and bring them to justice.
- Humanitarian intervention
  - Sending international teams to document crimes and assist survivors.
  - Providing urgent food and medical assistance to the displaced.
  - Provide psychological support and rehabilitation for victims, especially children.
  - Providing medicine, water, electricity and food
  - Supporting internally displaced persons
  - Provide protection for people wishing to leave and safe passage
- **International protection**
  - **Deploy international monitoring teams to protect targeted villages.**
  - **Pressure actors to stop attacks immediately.**

## Conclusion:

What is happening on the Syrian coast constitutes one of the most heinous sectarian crimes in the modern era. The evidence and testimonies collected confirm a clear intention to commit genocide, which requires urgent international action to stop these massacres and hold the perpetrators accountable.

Failure to act will lead to more bloodshed and allow sectarian violence to spread in the region. We call on the international community, especially the United Nations and human rights organizations, to take immediate steps to ensure the protection of civilians and hold the perpetrators of these crimes accountable under international law.
